In 2013 she was awarded the Queen's Diamond Jubilee Medal and was appointed to the Order of Ontario for her advocacy work re violence against women. She has been involved in the area of boundary violations and sexual abuse by authority figures for over 25 years. She has designed courses for medical students, residents, health care professionals, and teachers. She has acted as an expert witness in cases of sexual abuse of adults as well as the adult consequences of being sexually abused as a child.
